The shower room is fully tiled with easy clean glass and both overhead and hand held shower heads. There is also a built in vanity unit with mirror and thermostatically controlled heated towel rail.

The apartment features underfloor heating throughout and is installed with a heat recovery unit ensuring maximum heat efficiency.
