A storm porch opens into a welcoming sized entrance hallway with WC, off which are the principal reception rooms. The property has an attractive symmetry with the living room accessed by double glass panel doors, positioned at the front with bay window and match double doors through to the dining room with rear French doors. The large open plan kitchen breakfast/family room is noticeably light and provides sociable space enjoying garden views and access; benefiting from a full complement of built in appliances, including double oven, gas hob, integral fridge, freezer and dishwasher. Off the kitchen is a useful utility room with both side and garage access. Under-stairs storage.

1st floor: Good sized part-galleried landing. 4 double bedrooms; 3 housing fitted wardrobes. The main bedroom suite boasts en-suite shower room + dressing area. A family bathroom includes bath and separate shower. Airing cupboard.

Externally there is a double width tarmacadam driveway with space for parking for several cars, leading to an integral double garage.
